this Earth treats her better than me and then I sent her



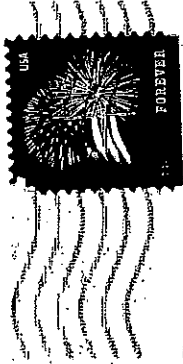
