NOTICE OF HEARING

PLEASE TAKE NOTICE that Defendant Robert F. McDonnell hereby requests a hearing on Tuesday, March 18, 2014 at 10:00 a.m., or as soon thereafter as counsel may be heard, on the following Motions: (1) Motion Seeking Immediate Discovery of all Exculpatory and Impeachment Evidence Pursuant to *Brady v. Maryland* and its Progeny (Doc. 9); (2) Motion for the Production of Evidence and Other Relief to Remedy the Government's Interference in the Defense's Investigation (Doc. 51); and (3) Motion for Discovery of Selected Recordings of Communications Between Prosecutors and Members of the Grand Jury (Doc. 8). Counsel for Maureen G. McDonnell and the Government are both available for a hearing on this date should the Court order one.

Defendant Robert F. McDonnell further provides notice that he intends to file a Motion to Dismiss the Indictment on or before March 25, 2014 and will request a hearing on that Motion. Because the legal issues in the Motion to Dismiss will substantially overlap with the legal issues in Mr. McDonnell's Motion for Discovery of Grand Jury Communications (Doc. 8), it may be more convenient for the Court—and better serve the interests of judicial economy—to hear these Motions together at a later date. The defense stands ready to argue this Motion on March 18,

however, should the Court grant its request for a hearing and prefer for the parties to argue this Motion at that time.
